File: Snapback Option 2008

Dear Sirs and Brothers:

This is to advise that the BLET "Snapback Option" recently distributed for a vote has failed to ratify. Ballots were sent to 98 BLET BNSF Divisions with 88% of the Divisions returning a ballot. Accordingly, the final vote count was 32 votes in favor and 55 votes against. While the vote count was based on a total "BNSF" basis, it is noteworthy that the returned ballots also showed that the snapback option failed to ratify on each of the four General Committees individually.

As a result of the vote, each of the four General Committees will be governed by BLET/BNSF Letter of Understanding dated February 25, 2008, previously distributed, which retains our right to vote the snapback option next year after reviewing BNSF's 2009 publicly announced first quarter financial results. Attached you will find the tally sheet for our General Committee.
